Sub.: Reg.-Training to Judicial Officers on "Cyber Security Investigation" by I4C, MHA.

Ministry of Home Affairs has set up the Indian Cyber Crime Coordination Centre (I4C) to create an effective framework and ecosystem for prevention, detection, investigation and prosecution of cybercrime in a comprehensive and coordinated manner. In one of the verticals of I4C i.e. National Cybercrime Ecosystem Management Unit, it is enjoined to create an ecosystem for prevention of cybercrime. Accordingly, a five days residential training program for Judicial Officer on the topic "Cyber Security Investigation" is being organized at Sardar Vallabh Bhai Patel National Police Academy (SVPNPA), Hyderabad during the period 05.06.2023 to 09.06.2023.
