Modalities of the one-day workshop/in service training for the cluster districts:

- 1. Every presenter will get 15 minutes for the presentation of the topic allotted to him/her.
- 2. Total time for presentation per topic would be 45 minutes.
- 3. All the three presenters of the given topic will wrap up their presentation within 45 minutes and thereafter the floor will be open for discussion.
- 4. Duration of the discussion will be 1 hour 15 minutes.
- 5. The three presenters of each topic shall discuss among themselves regarding the areas of their presentation and divide the topic amongst themselves so as to avoid repetition of any law point.
- 6. The presenters shall prepare themselves to meet the queries put forth by the participants during the open discussion.
- 7. The presenters will prepare the presentation in such a way that it strictly adheres to the time limit of 15 minutes per presenter allotted to each one of them.
